
These outcomes underscore the vast potential for higher education, starting with value education as a foundation, progressing toward value-based education, and ultimately fostering value-based living.

Survey Results: Indicate positive outcomes such as enhanced holistic perspective, emotional resilience, and a deeper understanding of harmonious co-existence with nature and society.


Educational Recommendations: Highlight the need for integrating value education into the broader curriculum of higher education institutions universally. This integration aims to promote value-based living and a more humane culture.







IX- Analysis of the Survey


The survey results clearly show the visible impact of the various proposals discussed during the teaching of UHVPE course. The detailed analysis is as follows-


























The survey analysis of the Human Values course reveals several key insights:
